

Privacy Statement Jakelu Distribution Service	
<p>This Privacy Statement describes, in accordance with the General Data Protection Regulation (EU) 2016/679, how the Bank of Finland/Financial Supervisory Authority (FIN-FSA) processes the personal data of data subjects stored in this personal data file system and the rights of the data subjects.</p>

3. Purpose of the processing of personal data and the legal basis for the processing	
To maintain a list of persons who have accepted the end-user licence agreements of applications downloadable from the service. To maintain a list of contact persons for official reporting.	
4. Categories of data subjects and categories of personal data	
<p>To download an application from the service, the end-user licence agreement of the application must be accepted. The name, email address and company of the person accepting the agreement is stored in the system's database.</p> <p>The first name, last name, telephone number and email address of those registering as a data provider's contact person are stored in the database.</p> <p>The database otherwise contains data on the installation packages of the applications provided and the login credentials of the personal data file system's data providers.</p>	
5. Recipients or categories of recipients of the personal data	
Personal data are not transferred outside the Bank of Finland or the FIN-FSA	
6. Notification of possible transfer of personal data to a third country or an international organisation	
Personal data are not transferred outside the EU or the EEA or to international organisations.	
7. Period for which the personal data will be stored or the criteria used to determine that period	
Personal data related to end-user licence agreements of applications downloadable from the Jakelu Distribution Service are stored for 10 years.	

Persons registering as a data provider's contact person are themselves obliged to maintain their contact details and otherwise inspect and correct or erase them, if necessary.

8. General description of technical and organisational security measures

In order to protect personal data against unauthorised access, disclosure, destruction or other unlawful processing, appropriate technical and organisational security measures are used, taking potential risks into consideration. These measures include the use of secure equipment premises as well as administrative and technical information security solutions.

9. Rights of data subjects

Personal data can be examined in the Jakelu Distribution Service.
 The instructions of the Jakelu Distribution state that data providers are themselves obliged to maintain their contact details and otherwise inspect and correct or erase them, if necessary. If necessary, an inspection request is presented to the contact person of the personal data file system. An inspection request must be sent in writing and the request signed by the person in question (identity must be verified).
 Data provided as a result of an inspection request will be given in writing and delivered by post to the address reported by the person in the personal data file system.

10. Statutory or contractual requirement to provide data and consequences of failure to provide such data

If a user does not provide information necessary for registration, the user cannot use the service.
