<p>This Privacy Statement describes, in accordance with the General Data Protection Regulation (EU) 2016/679, how the Financial Supervisory Authority (FIN-FSA) processes the personal data of data subjects stored in this personal data file system, and the rights of the data subjects.</p>

3. Purpose of the processing of personal data and the legal basis for the processing
<p>Personal data is processed in order to receive feedback on the introduction of the FIN-FSA's new Reporting System and on user training and instructions, and also to respond to feedback. The feedback received is used to develop the Reporting System and improve the FIN-FSA's activities. The legal basis for processing the personal data is therefore the performance of a task related to the general interest of the FIN-FSA.</p>
4. Categories of data subjects and categories of personal data
<p>Categories of data subjects:</p> <ul style="list-style-type: none"> - Respondents to the survey <p>Categories of personal data:</p> <ul style="list-style-type: none"> - Name, entity, email address, telephone number, answers to the survey and communication with the data subject. <p>Data are received from the data subjects themselves.</p>
5. Recipients or categories of recipients of the personal data
<p>The FIN-FSA does not forward data to other parties. Personal data may, however, be disclosed in possible requests for information insofar as the data are public on the basis of the Act on the Openness of Government Activities (621/1999).</p> <p>The Bank of Finland uses the following data processors:</p> <ul style="list-style-type: none"> - IT service providers - Communication service providers.
6. Notification of the possible transfer of personal data to a third country or an international organisation

Data are not transferred outside the EU or the EEA or to international organisations.
7. Period for which the personal data will be stored or the criteria used to determine that period
Personal data are stored for a maximum of one year after the completion of the survey.
8. General description of technical and organisational security measures
In order to protect personal data against unauthorised access, disclosure, destruction or other unlawful processing, personal data are processed in systems protected with appropriate technical security measures, taking risks into consideration. Manual material is located in premises to which unauthorised persons are prevented from accessing. Only those employees who need to process personal data in order to perform their duties have access to the personal data being processed.
9. Rights of the data subjects
The data subjects have the right: <ul style="list-style-type: none">– to request from the controller access to personal data concerning them and the right to request the rectification or erasure of such data or to restrict or object to processing.– to lodge a complaint about the processing of personal data with a supervisory authority.
10. Statutory or contractual requirement to provide information and consequences of failure to provide such information
Participation in the survey is voluntary. If the data subjects do not provide the information requested on the form, they cannot respond to the survey.
